- Maiden classes are for the horse/rider pair who have not won a blue ribbon in the level entered. Please specify desired test on entry form for any Test of Choice (TOC) class.
- Gaited horses will be scheduled in the same class as other horses at their respective levels.
- Tests will be ridden in a large arena unless noted online. If two rings are used, introductory and training level test 1 & 2 *MAY BE SCHEDULED IN A SMALL 20x40m arena*. Competitors will be notified when times are published online and via email.
- Show will follow USEF/USDF rules.
- **ONE HORSE/RIDER PER ENTRY**
- Jr. Riders and Adults will be divided in the Introductory Level and Training Level Divisions for pining. All other classes will combine Junior Riders and Adults unless there are 6 or more junior riders and 6 or more adult entries in a class. Second Level and above may be combined.
- Ride times will be available one week before the event date at [www.nhdea.org](http://www.nhdea.org) & emailed to competitors.
